Description

The site comprises a rectangular shaped residential site totaling approximately 0.5 acres (21,315 sqft), within which there is a 1,270 sqft two-storey residential dwelling in addition to a number of outbuildings currently used as a workshop, storage and for recreational purposes. A number of the nearby properties on The Common are already in used for commercial purposes. Subject to planning, this property / site may also be used for such. Location

The site is situated within the London Borough of Hillingdon and located on the south side of Donkey Lane which is accessed via Cricketfield Road. Junction 4 of the M4 motorway is approximately 2 miles to the east offering easy access to the M25 and the national motorway network. It is approximately 1.5 miles from Yiewsley Town Centre and West Drayton main line station and 3.5 miles from Heathrow Airport.

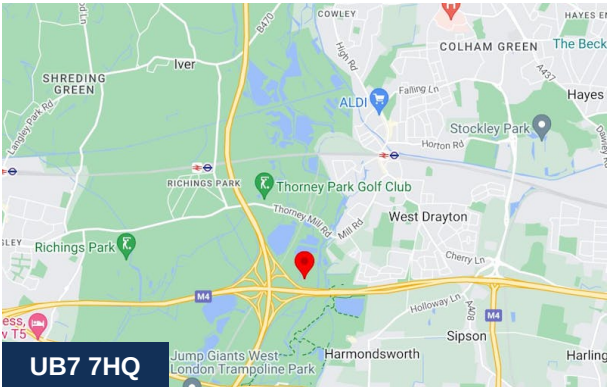
