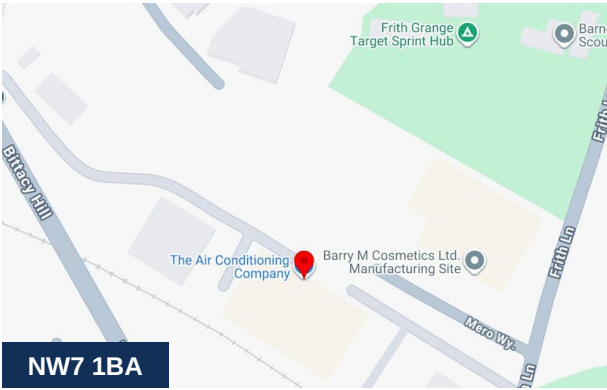
Location

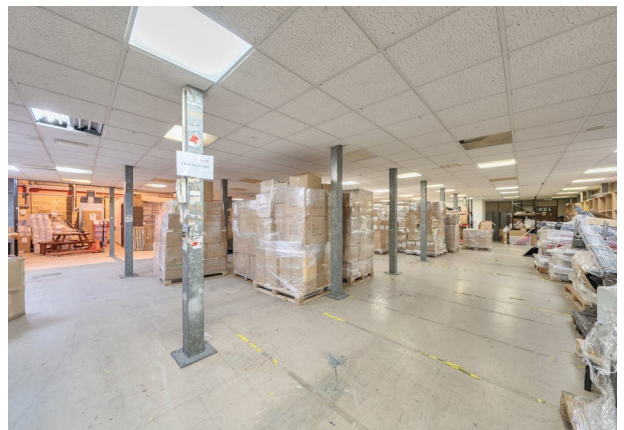

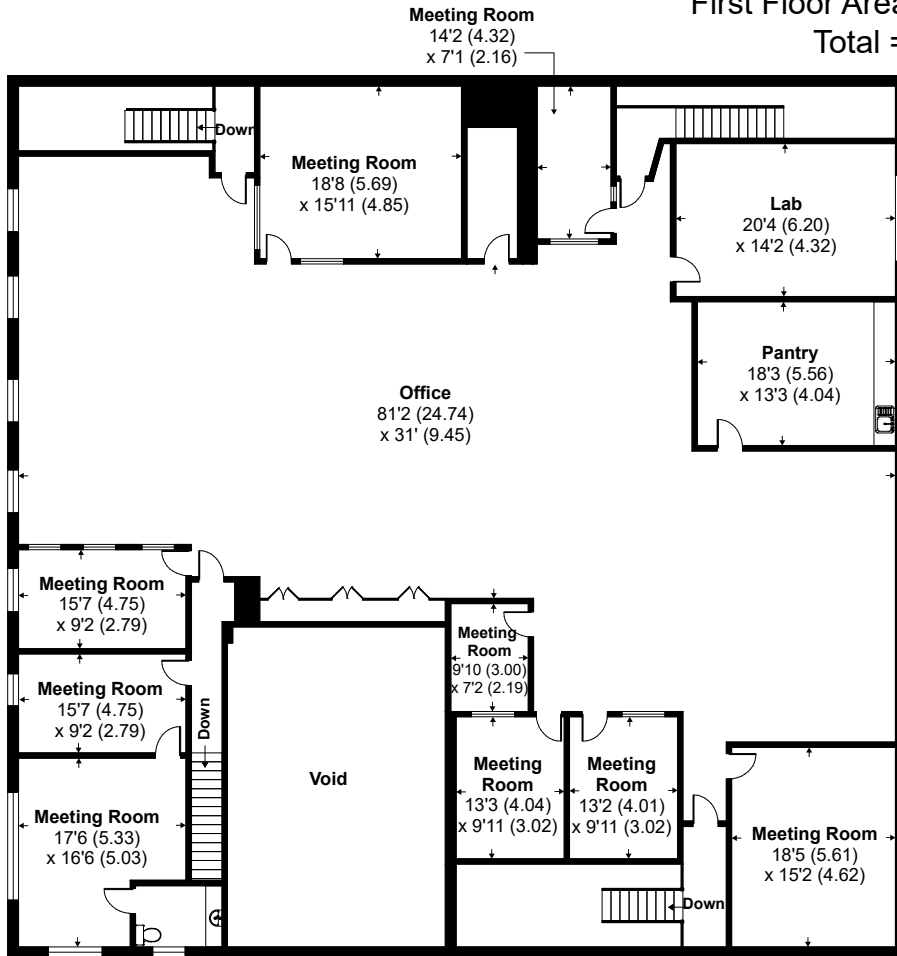

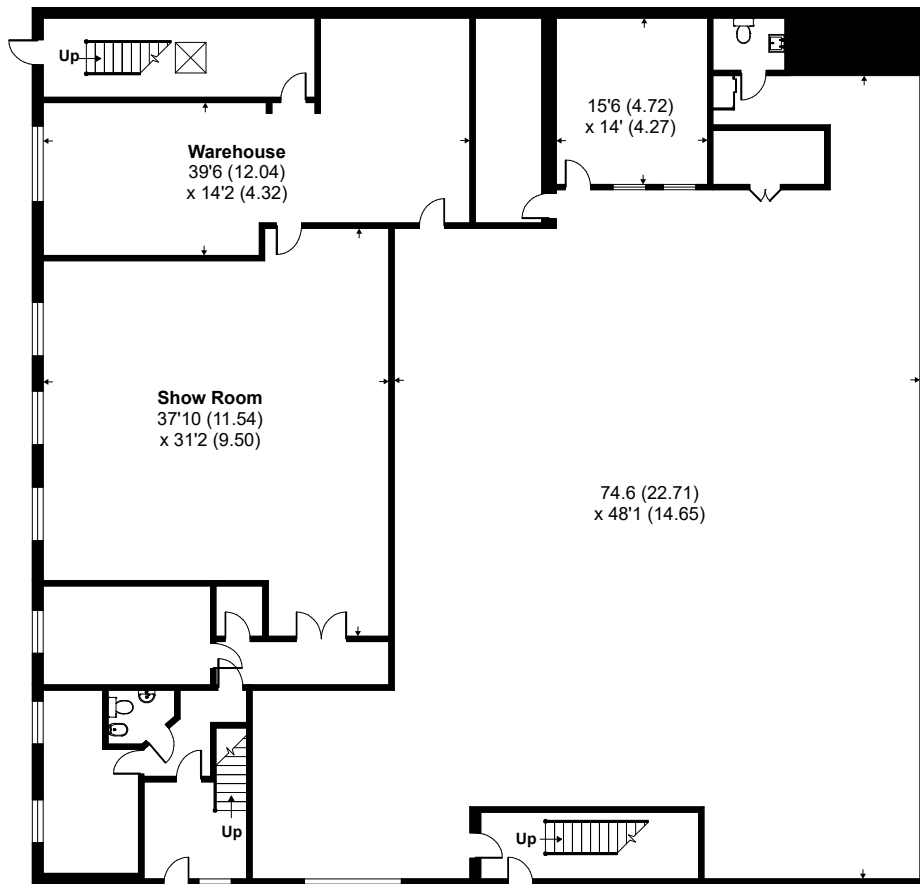
